ORDERS

- The Customer must place all Orders in writing. Spectrum Print may accept or decline an Order. The Price specified in the Order is subject to adjustment in accordance with clause 2 above. The Customer is bound to pay the Price from the time that an Order is placed. No Order may be altered, suspended, or cancelled, except with Spectrum Print's agreement, and then only on such terms as Spectrum Print may require, in its

Spectrum Print will use all reasonable endeavours to provide a commercially acceptable finished product consistent with good industry

 Spectrum Print will not be liable in anyway whatsoever, including negligence, for errors or omissions arising from an oversight or misinterpretation of a Customer's verbal instructions, or where a proof has been approved by the Customer.
